#### The second information letter

Dear colleagues!

The XVII International Scientific and Practical Conference of Russian Society for Ecological Economics
"Global Challenges and National Environmental Interests:

Economic and Social aspects" (RSEE —2023)

will take place from 3 to 8 July 2023
at the Institute of Economics and industrial Engineering SB RAS (IEIE SB RAS) and Novosibirsk state University (NSU) in Novosibirsk (Russia)

Russian Society for Ecological Economics (http://rseeorg.ru) was established in 1993 with the aim of organizing a platform for communication between scientists, graduate students, students, representatives of business and public administration. The results of fundamental and applied research on environmental economics are discussed at the Society's conferences. 2023 marks the 30th anniversary of the founding of the Russian Society of Ecological Economics.

The Society's conferences were held in Moscow and Irkutsk (1993), Pereslavl-Zalessky (1995), Novgorod (1997), Saratov (1999), Moscow (2001), on lake Baikal (2003), St. Petersburg (2005), Sochi (2007), Barnaul (2008), Kaliningrad (2009), Kemerovo (2011), Irkutsk (2013), Kazan (2015), Petrozavodsk (2017), Stavropol (2019) and Krasnoyarsk (2021). The Society unites researchers in environmental economics of the

country's leading universities and scientific research centers. In addition to Russian researchers, foreign representatives take an active part in the work of the Society.

The upcoming conference will be devoted to discussing topical issues of global, national and regional environmental policy, sustainable development of territories and sectors of the economy, including problems, prospects, indicators and goals of transition to a "green" economy and low-carbon development, as well as features of their adaptation to modern conditions. Within the framework of the conference, it is planned to get acquainted with modern environmental innovations. The possibilities of interaction between government, business, and the banking system in addressing environmental and economic problems will be considered. Particular attention will be paid to the most important issues of the modern agenda: the problems of effective resource development in the Arctic zone of Russia; the prospects of the national project "Ecology"; Russia's participation in the commitments of the Paris Climate Agreement in 2015; economic, environmental and social impacts of the pandemic; the need and opportunity to decarbonize the Russian economy in the current situation.

**Section 1.** Topical issues of sustainable development and "green" economy in the context of modern challenges

Section 2. Global and national environmental policies: indicators and directions of implementation

**Section 3.** Problems of rational nature management, low-carbon development in the conditions of climate change

**Section 4.** Problems of sustainable development of territories and industries: socio-economic and environmental aspects

**Section 5.** Business in the face of global climate and environmental problems: tools and mechanisms for solutions. Environmental innovations.

# Rules for preparation of materials

The volume of the paper - 10-20 thousand characters with spaces, including all elements (information about the authors, title, abstract, keywords, reference list).

The text editor is Microsoft Word. The format of the page - A4. Font - Times New Roman, font size - 12 pt. Line spacing - single spacing.

The text is aligned to the page width. The indent of the red line - 10 mm. All margins - 2 cm.

The first line shows the JEL code with an indentation.

Below, after the empty line - initials and surnames of the authors in lower-case bold letters, alignment to the center of the page.

Below - the place of work or study (institution, city, country), alignment to the center of the page.

Below, after the empty line - the title of the article in lower-case bold letters, alignment to the center of the page.

Below, after the empty line - the abstract of 150-250 words.

Below - keywords (up to 7 words).

Below, after the blank line - the text of the article.

Use the built-in features of Microsoft Word: Equation or MathType to create formulas. Formulas should be numbered. Figures and graphs should have a clear image. Figures and tables should be inserted in the text of the article. A blank line should be left between them and the text. The caps of tables should not be toned, nor printed in bold type. Separate cells of tables can be highlighted in color only if the tone carries any semantic load. The names and numbers of the figures are indicated below the figures, in the center. Titles and numbers of tables are above the tables, centered. Sources of information for tables and figures are indicated below them, in italics, centered. Tables, figures and formulas must not extend beyond the page (to the margins).

Reference to the source of funding (if necessary) is placed at the end of the text of the article. Bibliographical references should be in square brackets, for example: [Ivanov, 2008, p. 64]. The list of references is placed at the end of the article and is alphabetical. Requirements for the design of references are given in the sample in Appendix 2.

The list of references is followed by information about the authors: full name, degree, title, position, place of work.

# Issues of spatial development of Russian economy in studies of the Novosibirsk regional science school

Abstract. The article gives a brief description of the model apparatus used in the Institute for the analysis of spatial economic development and presents the key features of the methodology: scenario analysis, coalition analysis (calculations on all possible subsets of regions of the system), economic equilibrium, cooperative game. Some results of calculations on the data for the Soviet Union before the collapse and for the modern Russia are given briefly. It is shown that the degree of homogeneity of the economic space is growing, but remains very high. In the foreseeable future the regions-donors will be Far Eastern, North-Western, Ural and Siberian Federal districts. The principal recipient with a huge "inflow" effect is the Central Federal district.

*Keywords:* input-output model, multiregional model, effects of interregional interactions, coalition, equivalent and mutually beneficial exchange.
